

OFFICIAL RULES FOR THE THIRD STREET BREWHOUSE MINNESOTA GOLDEN TICKET CONTEST SWEEPSTAKES

PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. PARTICIPATION IN THE SWEEPSTAKES CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THESE OFFICIAL RULES. Sponsor:

Third Street Brewhouse (“Sponsor”) is the sole Sponsor of this sweepstakes. Trademarks and trade names used are for the purpose of prize description only and remain the property of their respective owners who do not endorse sponsor products and who are not affiliated with the sweepstakes. The Minnesota Vikings logo and the National Football League trademarks and copyrights are proprietary to the NFL Entities. All rights reserved.

Sweepstakes Period:

The Contest (sweepstakes) begins at 12:01 a.m. (CST) October 15, 2018 and ends at 11:59 p.m. (CST) December 31, 2018 (the Sweepstakes Period). Sponsor’s computer server is the official time-keeping device for the Sweepstakes.

Eligibility:

Sweepstakes entrants must be U.S. residents over 21 years old at time of entry. One (1) sweepstakes winner per household. All employees, officers, directors and agents and their immediate families or any members of their households, regardless of relationship, of Sponsor or any advertising agency or other company involved with the design, production, execution or distribution of this Sweepstakes are not eligible to participate in the program or to win any prize.

Any entry received from an ineligible participant will be deemed void. By submitting an entry or accepting a prize, participants accept and agree to be bound by these rules and the decisions of the Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Sweepstakes in any way at any time, subject to state or federal law.

How to Enter:

All entries require the purchase of 12-pack of Minnesota Gold Lager available only from Third Street Brewhouse and authorized distributors.

- During the Sweepstakes Period, purchase a 12-pack of Minnesota Gold Lager from Third Street Brewhouse or through an authorized distributor.
- All eligible participants who purchase a package of Minnesota Gold Lager that contains a Golden Ticket will be granted instant WINNERS of the Third Street Brewhouse Minnesota Golden Ticket PRIZE PACKAGE.

- To receive their prize, recipients must go to thirdstreetbrewhouse.com during the Sweepstakes Period and enter their unique Sweepstakes code into the Sweepstakes code field on the website. Fill in required information as directed by the website.
- By entering their code and all required information on the website, each Golden Ticket recipient is entered to win the GRAND PRIZE.
 - One (1) entry per Golden Ticket recipient.

Alternative Method of Entry

No purchase necessary. If eligible and a resident of the United States, a person may enter the promotion without making any purchase by hand-writing clearly and legibly in block capitals on a piece of plain paper “Minnesota Golden Ticket Promotion Entry” together with the person’s name and address and postcode and then signing and sending it in a properly stamped, handwritten envelope addressed to – “No Purchase Necessary – Third Street Brewhouse Minnesota Golden Ticket Promotion” to 219 Red River Ave. N., Cold Spring, MN 56320.

All entries must be received during the Sweepstakes Period. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods.

Prizes and Selection of Winners:

There are twenty (20) PRIZE PACKAGES awarded to winners of the Golden Ticket Sweepstakes and one (1) of these recipients will also receive the GRAND PRIZE of two (2) tickets to the Minnesota Vikings game. Odds of winning are dependent on the number of eligible entries received.

 - Approximate retail value of the prize package is \$50
 - Prize Packages to be picked up by winners at the Third Street Brewhouse

The Third Street Brewhouse Minnesota Golden Ticket Contest Sweepstakes GRAND PRIZE WINNER (1 [one] total) will receive:

- Two (2) tickets to a Minnesota Vikings game of choice that is mutually agreed upon by the grand prize winner and the Sponsor.

Approximate retail value of this prize is \$400

Prizes cannot be redeemed for cash. No substitution of prizes is permitted. Prizes are not transferable. Only one (1) sweepstakes winner per household. Sponsor will notify each Prize Package Winner individually by phone or email. Each Prize Package Winner must respond within forty-eight (48) hours of being notified or their prize may be forfeited. The Grand Prize Winner will be selected from a random drawing by Sponsor on January 2, 2019. Sponsor will contact the Grand Prize Winner individually by phone or email. The Grand Prize Winner must respond within forty-eight (48) hours or their prize may be forfeited, and another entrant chosen. Grand Prize recipient is responsible for transportation.

Failure to complete these forms may result in forfeiture of the prize. In the event that the potential winner is disqualified for any reason, the Sponsor or designee may select an alternate potential winner by random drawing from among all remaining eligible entries.

Publicity Release:

Winners agree that the Sponsor and their designees may use the name, voice, city/state of residence, photograph and/or likeness of the winner and any guests for advertising and/or trade and/or for any other purpose in any media or format now or hereafter known without further compensation, permission or notification.

Limitation of Liability and Dispute Resolution

Except where prohibited, each entrant accepting a prize agrees that: (a) all issues and questions concerning these rules shall be governed by Minnesota law without giving effect to any principles of conflicts of law of any jurisdiction; (b) any and all disputes, claims and causes of action at law or in equity arising out of or relating to this program or any prize awarded shall be (i) resolved individually, without resort to any form of class action; and (ii) filed only in the state courts situated in Minnesota, and entrant hereby consents and submits to the personal jurisdiction of such courts for the purposes of litigating any such disputes, claims or causes of

action; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (d) under no circumstances will any entrant be permitted to obtain awards for and hereby waives all rights to claim punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased and (e) Sponsor and Minnesota Vikings are not responsible or liable for any loss, damage, inconvenience, or loss of time arising out of any acts, omissions, or negligence, of any person including, without limitation, air and ground transportation carriers, the game venue, the players participating in the game, and any person providing any service or accommodation in conjunction with the prize, or for delays or cancellations including, but not limited to, those resulting from mechanical breakdown, closings, strikes, government action, inclement weather, sickness, injury, Acts of God, an act of terrorism, or a civil disturbance.
