

## **OFFICIAL RULES FOR THE THIRD STREET BREWHOUSE MINNESOTA GOLDEN TICKET CONTEST SWEEPSTAKES**

**PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. THIS SWEEPSTAKES IS VOID WHERE PROHIBITED BY LAW. ### **Sponsor:**

Third Street Brewhouse (“Sponsor”) is the sole Sponsor of this sweepstakes. Trademarks and trade names used are for the purpose of prize description only and remain the property of their respective owners who do not endorse sponsor products and who are not affiliated with the sweepstakes. All rights reserved.

### **Sweepstakes Period:**

The Contest (sweepstakes) begins at 12:01 a.m. (CST) July 1, 2019 and ends at 11:59 p.m. (CST) September 30, 2019 (the Sweepstakes Period). Sponsor’s computer server is the official time-keeping device for the Sweepstakes.

### **Eligibility:**

Sweepstakes entrants must be U.S. residents over 21 years old at time of entry. One (1) sweepstakes winner per household. All employees, officers, directors and agents and their immediate families or any members of their households, regardless of relationship, of Sponsor or any advertising agency or other company involved with the design, production, execution or distribution of this Sweepstakes are not eligible to participate in the program or to win any prize.

Any entry received from an ineligible participant will be deemed void. By submitting an entry or accepting a prize, participants accept and agree to be bound by these rules and the decisions of the Sponsor, which shall be final on all matters. Sponsor reserves the right to modify the rules of the Sweepstakes in any way at any time, subject to state or federal law.

### **How to Enter:**

All entries require the purchase of 12-pack case of Minnesota Gold Lager available only from Third Street Brewhouse and authorized distributors.

- During the Sweepstakes Period, purchase a 12-pack case of Minnesota Gold Lager through an authorized Third Street Brewhouse distributor.
- All eligible participants who purchase a package of Minnesota Gold Lager that contains a Golden Ticket will be granted instant WINNERS of the Third Street Brewhouse Minnesota Golden Ticket PRIZE PACKAGE.

- To receive their prize, recipients must go to [thirdstreetbrewhouse.com](http://thirdstreetbrewhouse.com) during the Sweepstakes Period and enter their unique Sweepstakes code into the Sweepstakes code field on the website. Fill in required information as directed by the website.
- By entering their code and all required information on the website, each Golden Ticket recipient is entered to win the GRAND PRIZE.

All entries must be received during the Sweepstakes Period. Sponsor is not responsible for lost, misdirected, late, unsent, incomplete, illegible or unintelligible entries or for inaccurate entry information, whether caused by participant or by any of the equipment or programming associated with or utilized in this entry, or by any technical or human error that may occur in the transmittal of any entry or the processing of any function on the participant's mobile device. Entrants must notify Sponsor of any changed mobile device number or email address within the Sweepstakes Period to remain eligible. Sponsor reserves the right, in its sole discretion, to disqualify any individual found to be tampering with the entry process or the operation of the entry; to be acting in violation of these rules; or to be acting with intent to annoy, abuse, threaten or harass any other person. Any use of robotic, automatic, programmed or similar entry methods will void all such entries submitted by such methods.

**Prizes and Selection of Winners:**

**Publicity Release:**

**Limitation of Liability and Dispute Resolution**
